Park Report by Tony

1.3 Financial Report: (Jerry Agee)

- **Income:** Line #7, Entertainment income is about \$1,100 more.
- Received enough donations to cover the cost of property taxes.
- Line #28, Tower used to be \$50 per month, now it is \$250 per month.
- Rental income for the year = \$30,885.00 less expenses of \$6,612.77 = \$24,272.23 net income.
- Line #59 Winterizing income of \$1,180.00
- **Expenses**: Line #19: Software updates will be \$100 per year.
- Line #29: Workers comp \$2,181.48 year to date.
- Line #32: \$275.70 is the Sales Tax/Beverage Permit to Delaware County.
- Line #36: The office building is paid off.
- Line #37: The property loan balance is \$282,198.98. A member asked what was the original amount? Answer: \$288,000. Pine Island was just paying the interest. Now Pine Island is paying principal and interest. 5% interest rate.
- Line #48: About 40 fire extinguishers were checked/maintained. Cost was approximately \$1450
- Line #67: Approximately \$770 for a new copy machine
- Line #80: Already saved \$4,300 which means the indoor pool heater has already paid for itself and there is about 30% of propane left in one tank.
- Line 96 & 97. The golf carts have helped on the fuel costs.
- New housekeeper has been hired.
